With aggregate only, the Plan funds their claims account to the monthly attachment point and pays one premium. There is no specific deductible, and all eligible Plan claims accrue to the Aggregate. If, by chance, claims exceed the accumulated attachment point, IAT will immediately advance funds for claims paid by the Plan in excess of the accumulated attachment point.
